SUPPLEMENTAL DECLARATION OF COVENANTS AND RESTRICTIONS

WHEREAS, it is the desire of the Developer that the properties hereinafter described as Tract No. 219 shall be covered as fully by the Declaration aforesaid as though said tract had been included with the other property described in said Declaration; and

WHEREAS, the Club is agreeable that said lands hereinafter described as Tract No. 219 shall be covered and included under the terms, provisions, assessments and liens as provided in the Declaration above referred to.
