Clerk and Recorder The undersigned, being the owners of all of RUSH ESTATES, BENTON COUNTY, ARK. a Subdivision of a part of Section 6, Township 20 North, Range 30 West, as shown at Benton County, Arkansas, Plat Record K at page 85 thereof, do hereby establish and create the following Protective Covenants, which shall take the place of those previously filed of record at Benton County, Arkansas, Deed Record 434 at page 499 thereof.

## COVENANTS

- A. Land Use and Building Type. No lot shall be used and no dwelling shall be erected, altered, placed, or permitted to remain on any lot other than for residential purposes.
- No dwelling shall be permitted on any B. <u>Dwelling Size</u>. lot in which the living area thereof is less than 1,600 square feet, including garage.
- C. Building Location. No building shall be located nearer to a lot line than 25 feet.

- F.
