The $N\frac{1}{2}$ of the SW $\frac{1}{4}$ and part of the SE $\frac{1}{4}$ of Section 16, Township 21 North, Range 28 West, Benton County, Arkansas.

- All tracts shall be sued for residential purposes only. No commercial enterprises shall be permitted.
- Tracts shall not be subdivided nor shall more than one residence be placed on any single tract.
- 3. No buildings shall be located on any tract within 100 feet of the property line.
- 4. Trash, garbage, and other waste shall not be kept upon any tract except in sanitary containers. No area shall be used or maintained for a dumping ground or storage area for rubbish, junk, trash, or appliances.
- 5. No inoperative, wrecked, abandoned or junk motor vehicles shall be permitted to remain upon any tract. Boats or trailers shall not be stored in visible areas which would detract from the general appearance of the community.
- 6. Livestock or poultry may be kept on said tracts for personal use only. Household pets may be kept provided that same are not deemed a nuisance to the neighborhood. All animals shall be restricted to owners property. Dogs shall not be allowed to run loose.
- 7. No timber is to be cut or removed from property.
- 8. All properties must be moved at least once a year.
- 9. Before a mobile home is moved on the property, a septic tank, water meter and electric meter must be hooked up.
